This letter is to confirm the listing of the above named fund on the National Association of Insurance Commissioners (NAIC) List of Approved Mutual Funds pursuant to Part 4, Section 8 (e) of the Securities Valuation Office (SVO) Purposes and Procedures Manual of the NAIC. The listing allows this fund to be reported on Schedule DA Part 1. Those funds designated as *U.S. Direct Obligations/Full Faith & Credit Exempt* listings are exempt from NAIC reserve requirements. Those funds designated as *Class 1* listings are to be reserved against as if they were a NAIC-1 Bond.

Annual Renewal

The NAIC List of Approved Mutual Funds listing cycle runs from July to June, therefore the fund's active status on the list shall extend through June 30 of the following calendar year. You are required to file an annual update renewal request with this office each year to remain on the NAIC List of Approved Mutual Funds. Notification to renew will be mailed to you approximately three months before the end of the 12-month cycle (on or around March 15th). You will be invoiced separately after our receipt of your renewal application and documentation. Failure to provide appropriate documentation and/or payment in a timely manner will result in the removal of the fund from the NAIC List of Approved Mutual Funds. **Please, note well, that to be reinstated you will be required to complete an initial filing application and to pay the initial filing fee of \$500.00.**
